

ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
THE CANDLELIGHTERS CHILDHOOD CANCER FOUNDATION

TO: Department of Consumer and Regulatory Affairs
Washington, D.C. 20001

Pursuant to the provisions of the District of Columbia Non-profit Corporation Act, the undersigned adopts the following Articles of Amendment to its Articles of Incorporation:

- FIRST: The name of the corporation is: The Candlelighters Childhood Cancer Foundation
- SECOND: The following amendment of the Articles of Incorporation was adopted by the Corporation in the manner prescribed by the District of Columbia Non-profit Corporation Act:

"That Article Seventh, Section D be amended to read:

D. The Corporation shall formulate, recommend, participate in, directly or indirectly, and advocate for either the adoption or rejection of local, state and federal legislation which is intended to assist and improve services for those effected by pediatric cancer or intended to assist and improve research programs relating to pediatric cancer and its effects. However, in no event shall the activities set forth in this section be or become a substantial portion of the total work of the Corporation."

- THIRD: The amendment was adopted in the following manner:

"The amendment was adopted by a consent in writing signed by all members entitled to vote with respect hereto."
